Page 8 – Patio – add the words or raised after patio slab.

Page 9 – move the drainage paragraph from Landscaping & Privacy Materials to under Gutters section. Remove the words "Prior to sodding".

Page 10 – Remove the sentence "The porch (patio) floor is a concrete slab.

Page 11 - Section 1 add the words "or factory" to the second sentence.

Page 11 - Section 2 add the words "or factory" to the second sentence.
